**INSTRUCTIONS FOR COMPLETING THE GEOCACHING/EARTHCACHING/LETTERBOXING APPLICATION**

1. Download the application online at <http://parks.ky.gov>
2. Meet with the park manager or his/her designee to select an appropriate location(s) for a geocache, earthcache or letterbox
3. Obtain the GPS coordinates for the location(s) being proposed. This is required for geocaches, earthcaches or letterboxes so we can accurately map the location for review/management purposes.
4. Mark the approximate location(s) on a park map as you will need to submit a map with your application. (*park maps are available at [www.parks.ky.gov](http://www.parks.ky.gov)*)
5. Submit completed application to park manager.
6. Park Managers - Scan completed permit and marked map and email to [RobertA.Myers@ky.gov](mailto:RobertA.Myers@ky.gov). Alternatively, a hard copy of the application and map can be sent via U.S. Mail to Geocaching Permits, KY State Parks, Capital Plaza Tower - 10th Floor, 500 Mero Street, Frankfort KY 40601
7. Review and approval/denial of the permit application may take **up to 30 days**. Applicant and [geocaching.com](http://geocaching.com) or [letterboxing.org](http://letterboxing.org) will be notified by e-mail or hard copy of division approval.
8. **Reminder:** caches or letterboxes may be established only after division approval has been received.
